POSTION SUMMARY

The Nutrition Program Food Handler at Beacon House is a part-time role that demands both excellent attentions to detail and the ability to work quickly on repetitive tasks without sacrificing quality. The position entails working with unpackaged foods and beverages and preparing them to be consumed by the students in Beacon House. The Nutrition Program Food Handler may work within various programming spaces. The main goal of the Nutrition Program Food Handler is to efficiently prepare food for consumption while still following all necessary food safety guidelines. To do this, the Nutrition Program Food Handler needs to be able to work with minimal supervision and maintain both their focus and quality. The ideal candidate is collaborative, flexible, extremely well organized, has strong problemsolving skills and loves checking tasks off their to-do list with great attention to detail. We are also seeking candidates who demonstrate the ability to model Beacon House's values: Community, Flexibility, Saving and Changing Student Lives, Students First, and Trust).

Food Handler Job Description

Beacon House is looking for a new food handler. Applicants will be asked to complete a questionnaire of food health and safety questions to demonstrate their skill set. You may be asked to receive and unpack deliveries, verify inventory, and discard any spoiled or contaminated food items. You will be responsible for getting our food ready for the students in our program. This will require a high level of attention to detail.

As a food handler, you will need to be knowledgeable of all food health and safety regulations and be able to work well in a team. A food handler's license is required to qualify for this position. Beacon House will provide all training needed to obtain a license.

This is a part-time position with work hours of 2:00-5:00 PM on Monday - Friday. There may be occasional additional hours for training and planning.

Food Handler Responsibilities:

- Follow all food health and safety guidelines and requirements
- Receive food deliveries on a daily basis at 2:30pm
- Maintain food preparation tools, including cleaning and disinfecting instruments and equipment before and after use
- Maintain the cleanliness of all surfaces involved in the food handling process, such as counters, ovens, freezers, and microwaves
- Clean up any spills and leaks that may occur
- Follow procedure to prevent food spoilage and waste
- Prepare food rotation labels and use them to ensure optimal use of our key ingredients
- Assist with completing nutrition program applications, managing program compliance, and monitoring, and attending all related training. Including being a point of contact for kitchen operations and ensuring that food safety guidelines are followed.

Food Handler Requirements:

- High school diploma or GED
- Either currently hold or successfully pass the training to obtain a food handler's license
- Previous experience with handling food is preferred
- Knowledge of the latest food health and safety guidelines
- Ability to work well in a team
- Ability to maintain a high standard of quality in an unsupervised setting
- · Strong communication skills
